THE FUND OPERATES THE ST. JOSEPH STUDENT DEBT RELIEF GRANT PROGRAM FOR MEN AND WOMEN WITH VOCATIONS TO THE CATHOLIC RELIGIOUS LIFE (INCLUDING THOSE MONASTERIES OR OTHER COMMUNITIES WHOSE MEMBERS MAKE VOWS OF POVERTY, CHASTITY AND OBEDIENCE AS WELL AS THOSE IN SOCIETIES OF APOSTOLIC LIFE, WHOSE MEMBERS DO NOT MAKE SUCH VOWS) BUT WHO ARE PREVENTED FROM BEGINNING OR CONTINUING THEIR RELIGIOUS FORMATION DUE TO THEIR PRE-EXISTING STUDENT LOANS. IN 2024, THE FUND AWARDED 35 NEW GRANTS. IN TOTAL, 53 MEN AND 115 WOMEN WERE BENEFICIARIES UNDER THIS PROGRAM IN 2024.
