WITH VOCATIONS TO THE CATHOLIC RELIGIOUS LIFE (INCLUDING THOSE MONASTERIES OR OTHER
COMMUNITIES WHOSE MEMBERS MAKE VOWS OF POVERTY, CHASTITY AND OBEDIENCE AS WELL AS
